## **RENTAL TRAILER CONTRACT** **Terms and Conditions**

1. **General:** The Trailer is owned by Green Acre "Park" and is offered as holiday accommodation for the vacationer ("the Camper") for the period and upon the terms set out in the attached Trailer Rental Invoice.

3. **Cancellation:** Any cancellation by the Camper shall be in writing and mailed or faxed to the Park at the above address. On receipt of such notice of cancellation, the Park will use its best efforts to re-book the rental trailer for the entire period of the original booking.
  - (a) If the Park is successful in re-booking the rental trailer as per the original booking, the Park will refund all monies paid to the Camper minus a \$50.00 cancellation fee.
  - (b) If the Park is unsuccessful in re-booking the original booking, all monies paid by the Camper will be forfeited to the Park.
4. **Inventory and Trailer Do's and Don'ts:** An Inventory list will be available at each trailer upon occupancy; the Trailer Do's and Don'ts and Cleaning Check List, all form part of this Trailer Rental Agreement and are available at the Green Acre Park office for your review prior to confirming your trailer reservation.
5. **Access by Park Staff:** The Park Staff shall be allowed access to the Trailer at any reasonable time during any vacation. Staff will do maintenance check on the trailer every 10 days for any month or longer bookings.
6. **Repair:** The Camper shall keep the Trailer and all furniture and fixtures in or about the Trailer at the same state of repair and condition as at the start of the holiday, and shall leave the trailer as clean and in the general order in which it was found, and not to remove any furniture from the trailer. Failure to do so, or advising the Park of any damage or repairs required, will result in a damage/cleaning charge being levied.

7. Number of Persons Using the Trailer: The Trailer (sleeping accommodations, etc) is designed to accommodate a maximum number of people. Refer to the Trailer Information Sheet for the maximum of people. The number of people present overnight (including guests) shall not exceed such maximum, unless previously approved by the Park. All guests must register and pay visitor fees in the office. If site size permits, an additional tent may be placed on the site.
- (a) No smoking is permitted inside the Trailer  
 (b) i: Additional \$50.00 / per week fee for pets  
 ii: Pets inside the trailer must be in cages  
 iii: Pets outside trailer must be on leash
8. Keys: The Camper agrees to vacate the Trailer on-time and to return all keys to the office. Check-in time 4:00pm. Check-out time 11:00am
9. Disclaimer of Liability: The Park, Green Acre Park, or its employees or agents will not be liable whatsoever for any loss or injury to Campers, or any damage to the Campers property, however the said damage, loss or injury may be caused, whether by any act, omission, breach of contract or negligence or any other cause on the part of the Park. Use of the Trailer and all facilities in the Park is at your own risk.
